Regular Meeting Minutes

A motion was made by Director LeBorgne, seconded by Director McElroy to approve August 28, 2025, regular meeting minutes. The motion carried

August 2025 Financial Statement and the Account Manager's Report A motion was made by Director Davidson, seconded by Director LeBorgne to approve the August 2025 Financials subject to audit. The motion carried unanimously.

Manager Report: 2026 Preliminary Budget – As we discussed at last month's meeting, we

are moving forward with the preparation of the preliminary 2026 annual budget. With the assistance of Waterworth, I have been working diligently to ensure we have a comprehensive and realistic financial plan in place. Several line items have been increased to reflect operational needs and projected costs. As part of this process, a potential rate increase for water and sever services is also under consideration. I have been estimate.

and sewer services is also under consideration. I have been actively

consulting with Plant Operations Manager/ORC, Daryl Back, and Utilities Director, David Beecraft, to ensure all projections are well-informed and accurate. Additionally, I've been working closely with Waterworth to develop a preliminary draft budget that I will soon present to the Board for review and input.

Server Migration – We are now in the final stages of our server migration process. On Wednesday, all office staff's electronic documents will be converted and transferred to the new cloud server. We will use Thursday to verify that all systems and files are functioning properly. Once everything has been confirmed to be working correctly, Verticomm will proceed with decommissioning both the main server and the remote server. These servers will then be securely recycled.

Administrative Assistant Position – Management is currently accepting applications for the open Administrative Assistant position through Rifle Works and Mountain Temp. Unfortunately, we have not yet received any applicants who meet the required qualifications for the role. Management will continue actively searching and exploring additional recruitment options to fill this position with a qualified candidate.

New Business

Director Davidson made a motion, seconded by Director Suits, to approve a letter of support for non-motorized trail grant for the Parachute/Battlement Mesa Park & Recreation District. The motion carried unanimously.

Assistant Manager Morris presented the Preliminary Budget.
