Manager Report: Starlink Internet – We hired a cabling contractor, out of Grand Junction, to install the new Starlink internet service. As they were assessing, they found that Starlink did not send the correct mounting equipment. The original equipment allows for the equipment to sit on the ground. A ground mount is not conducive for our area due to the terrain. For Starlink to work properly, the equipment needs to be mounted on the outside of our building. The equipment was installed on Friday.

HB24-1344 – In June, we received notice from a couple of our Backflow Testers that a new bill was signed and went into effect on July 1st. This new bill states that all Backflow Prevention Device testers must also be licensed Journeyman Plumbers. Multiple major backflow testing companies along with several water purveyors are standing up to legislation in hopes that the Colorado State Plumbing Board will "refrain from issuing disciplinary actions until the implementation process for this bill is complete and the General Assembly can fully consider the unintended impacts of this bill." We have attached a letter to the State Plumbing Board from Denver Water to better explain the consequences and concern of HB24-1344.

Manhole Replacement Project: The project to replace two badly corroded sewer manholes in the Saddleback Village area has been completed. These two manholes were downstream from the two manholes replaced last year. One of the manholes was 23 feet in depth and the other 11 feet in depth. The contactor, M&A Concrete, used to replace the two manholes last year was once again contracted to remove the current manholes. As last year, the contractor did an excellent job, as we experienced no problems or issues, and the project was completed quickly. The cost to replace was approximately \$64,000.

Meter Pit Replacement Project: The project to replace meter pits in Saddleback Village has been completed. This project requires installing new water meter pits close to the street on the individual residential lots in the mobile home section. The existing meters in these areas are located underneath the mobile home and present difficult access issues for BMMD staff. The meters are being relocated to the new meter pits which provide easy access. A total of 25-meter pits were installed at a cost of \$75,000. This is the first part of a multi-year project.

Wastewater Blower Installation Project: Velocity, Inc., has been hired to complete the installation of the new aeration blower at the wastewater plant. This project requires the replacement of the existing 30 plus year old blower. The installation requires modification and replumbing of the existing blower related piping in the plant in order to accommodate the new blower. Velocity anticipates a mid-August start date and the approximate cost to complete the project is \$50,000.

New Business A motion was made by Director Davidson, Seconded by Director Mohrlang to approve the 2023 Final Financial Audit. The motion carried unanimously.
